- Students living independently: If the student is an adult or a mature minor for the purpose of enrolment and they live
 independently. These students will need to be considered in accordance with the <u>www.education.vic.gov.au/pal/decisionmaking-responsibilities-students/policy</u> policy.
- Adult Students: a student 18 years of age or older is considered an adult and can sign their own consent form.
